TERMS & CONDITIONS

- 1. The bidders must be registered with Tamil Nadu Government e-procurement system portal and also should Posses Digital Signature Certificate.
- 2. The online bids should be submitted directly by the original manufacturer / supplier, if the bid is submitted / filled / uploaded by any representative / agent / dealer then they must upload an Authorization Certificate from the OEM (Original Equipment Manufacturer) / Principal Company for quoting the price/participating tender, otherwise such bids shall be rejected.
- 3. All the items/Goods/Equipment/machineries/articles should be delivered to the college premises only.
- 4. Bidders should submit their bids in two bids system through online in prescribed format only.
 - **a) Technical Bid**: Shall be submitted along with scanned copies of necessary documents such as Brochure/Pamphlets/Detailed specifications.

b) Financial Bid:

- i. In xls format only (Excel Format).
- ii. Rate per unit should be mentioned separately.
- iii. All rates quoted should be in Indian Rupees (INR) only.
- 5. Bids in physical form or in any other manner will not be accepted.
- 6. The Bidders should Posses a valid GST identification number and PAN. The copy of the GST registration Certificate and PAN is to be submitted /

- uploaded. Non-Registered firms are not entertained and bids shall be rejected.
- 7. Incomplete / Not clear / bids shall be rejected.
- 8. Non execution of the order within the prescribed date will lead to cancellation of orders placed. The supplier may be black listed.
- 9. The payment will be made within reasonable time only after the receipt and installation of materials in good working condition in every aspect.
- 10. The quantity mentioned in enquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- 11. As per Tamil Nadu transparency in tender act 1998 and Tamil Nadu transparency in tender Rules 2000
